

# YOUNG ARTIST COMPETITION GUIDELINES- 2024

The Folsom Lake Symphony is proud to announce its second annual Young Artist Competition, the initial focus of the symphony's Emerging Artists Program. The competition, held at the Harris Center for the Arts at Folsom Lake College, will be judged by a panel of professionals chaired by the symphony's music director and conductor, Peter Jaffe. The competition is made possible thanks to the Georgette Pauwels and Réal Desrochers Grant for Emerging Artists.

Cash awards are given to the Division winners and the Grand Prize winner. All winners will perform at the Young Artists Recital. The Grand Prize winner will also perform with the Symphony at the Family Concert.

# AWARDS

All participants in the live competition will receive a Certificate of Participation.

Winners of the live competition will receive a certificate and a cash prize awarded at the Young Artists Recital.

The Grand Prize winner will perform with the Folsom Lake Symphony at the January 25, 2025, annual Family Concert.

All winners will receive a professional video clip of their performance at the recital for personal use.

Adjudication remark sheets will be provided to all live competition contestants after results have been announced.

In rare cases, the symphony reserves the right not to award the Grand Prize.

The Grand Prize winner cash award of \$1,000 and Division winner awards of \$500 each will be awarded after the soloists' required appearance.

## ELIGIBILITY

Applicant must be between the ages of 8 through 18 on the day of competition and reside in El Dorado, Nevada, Placer, Sacramento, San Joaquin, Sutter, Yolo, or Yuba counties, OR be a family member or student of a regular Folsom Lake Symphony musician.

Applicants must be highly accomplished orchestral instrumentalists, pianists, or vocalists.

Previous First Prize winners of Divisions I and II are NOT eligible to compete in the same division again but may re-enter the competition when eligible for the next age division.

Previous First Prize winner of Division III may compete again, but ONLY for the Grand Prize.

Previous Grand Prize winners are NOT eligible for this competition.

## DIVISIONS

The competition is divided into three age groups with audition time limits as follows:

Division I	Division II	Division III
Ages 8-11	Ages 12-15	Ages 16-18
6 Minutes	8 Minutes	10 Minutes

Instrumentalists, pianists, and vocalists will compete against each other within age group divisions.

Participants may compete on an additional instrument or voice if they are exceptionally developed in both areas.

## REPERTOIRE

Selection should be chosen to best represent the applicant's musicianship and talent. Candidates hoping for a Grand Prize appearance with the Folsom Lake Symphony should select a piece or movement lasting no more than 15 minutes. An obtainable orchestral accompaniment must exist.

The submitted audition piece must be the same as that performed at the live competition and recital – no substitutions.

## SUBMISSION REQUIREMENTS (email submissions only)

Audition Packet must include the following:

Completed application (use the fillable pdf form).

An unedited digital recording sent as a link (YouTube, Dropbox, etc.). Physical media will not be accepted. The recording should be clearly labeled with the applicant's name, age, title of the piece, movement, and composer.

A non-refundable entry fee of \$50. Payment must be made online at <u>www.folsomlakesymphony.com/yac/</u> by midnight September 30, 2024.

Exceptional applicants may participate in two categories by submitting two separate applications.

For repertoire requiring accompaniment, applicants must provide their own accompanist for the recorded audition, live competition, and recital.

The application packet must be received via email by midnight on September 30, 2024.

## LIVE COMPETITION

Perform the same composition as performed for the recorded audition.

For repertoire requiring accompaniment, applicants must provide their own accompanist for the live competition and recital. Repertoire that would not require an accompanist would be a piece specifically written as a solo composition, such as a solo piano sonata or solo (unaccompanied) instrumental sonata.

Adhere to the performance time limits for each division. Exceeding the limit may result in being stopped midperformance.

Provide scanned music score via email prior to live competition, to be distributed in advance to the judges.

Memorization of the music is required.

Contestants will be notified by 7 p.m., Sunday, November 10, via email.

The performance schedule and further directions will be sent to those advancing to the live competition.

# YOUNG ARTISTS RECITAL

All winners of the live competition receive a Certificate of Merit, a cash award, and a video of individual recital performance for their personal use.

All winners must perform at the Young Artists Recital or forfeit their monetary award.
